## LEAVING CERTIFICATE 2019 - RESULTS AND APPEALS SERVICES

## Dear Candidate,

Here is a brief reminder on the timings of next steps following the issue of the Leaving Certificate results. All of the detailed information that you need about accessing your results online, component marks, viewing scripts, (including scripts in subjects marked online which will available for viewing online) and appealing results can be found in the 2019 Candidate Information Booklet. You should have received a copy of this booklet before the examinations commenced. You can access an online copy on our website <a href="https://www.examinations.ie">www.examinations.ie</a>. The Candidate Information Booklet is a very important document as it sets out the SEC's policies and procedures following the issue of the Leaving Certificate results.

The Leaving Certificate appeal results will be issued in the week ending Friday 20<sup>th</sup> September this year. As this is so much earlier than before, the deadlines for applying to view scripts and to appeal results are all much earlier as a consequence. You should familiarise yourself with the Key Dates set out in the table below to ensure that you do not miss out on being able to access the post-results services as the deadlines will be strictly applied. You are responsible for ensuring that you submit your applications on time. No late applications will be considered.

Access to all of the results and post-results services will be through the SEC's new Candidate Self Service Portal (CSSP) on <a href="www.examinations.ie">www.examinations.ie</a>. If you have not already registered on the portal you should arrange to do so without delay. Registration is easy and there is an online step by step guide to take you through the process. To complete the registration, you will need your Examination Number, your Personal Identification Number (PIN), your mobile phone number and email address. A personalised PIN letter was issued to all candidates in May either to the school, in the case of candidates entered for the examinations through their school, or to the address that we have on record in the case of External Candidates. If you do not have your PIN and you attended a recognised secondary school you should ask the school for the PIN – in addition to the PIN letter we also provided a master list of PINs to be securely retained in the school.
